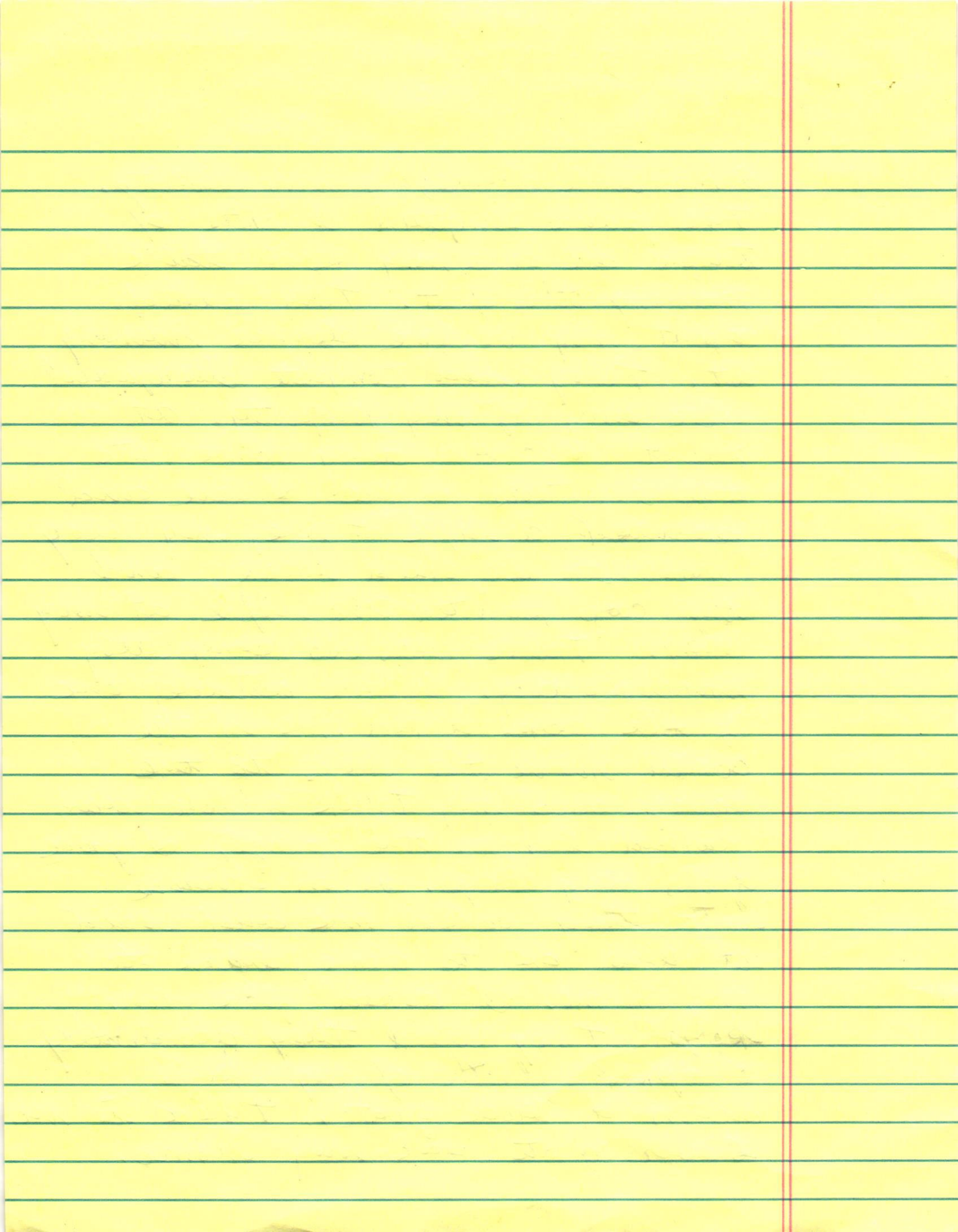

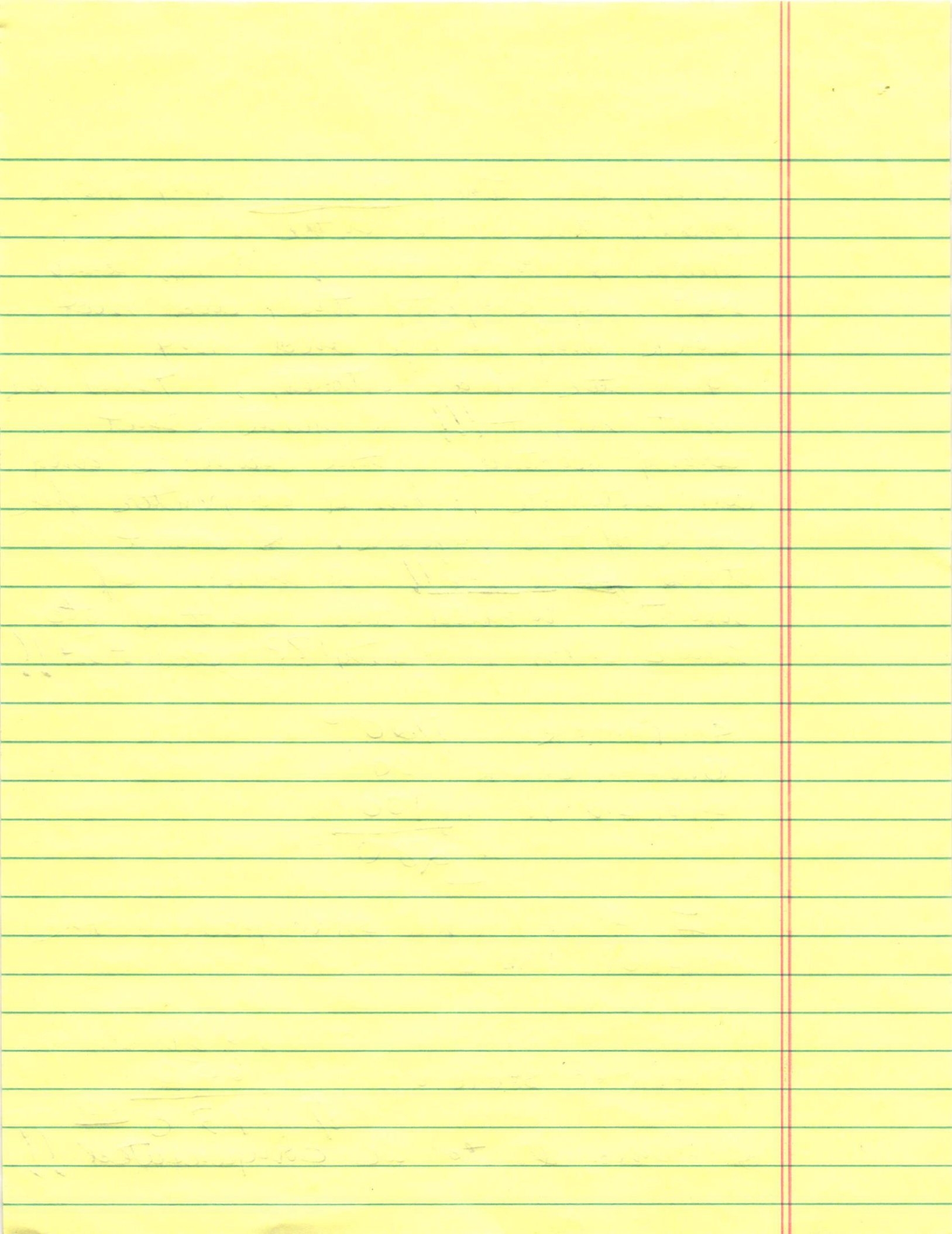
Why did they throw my keys

Terms and Conditions

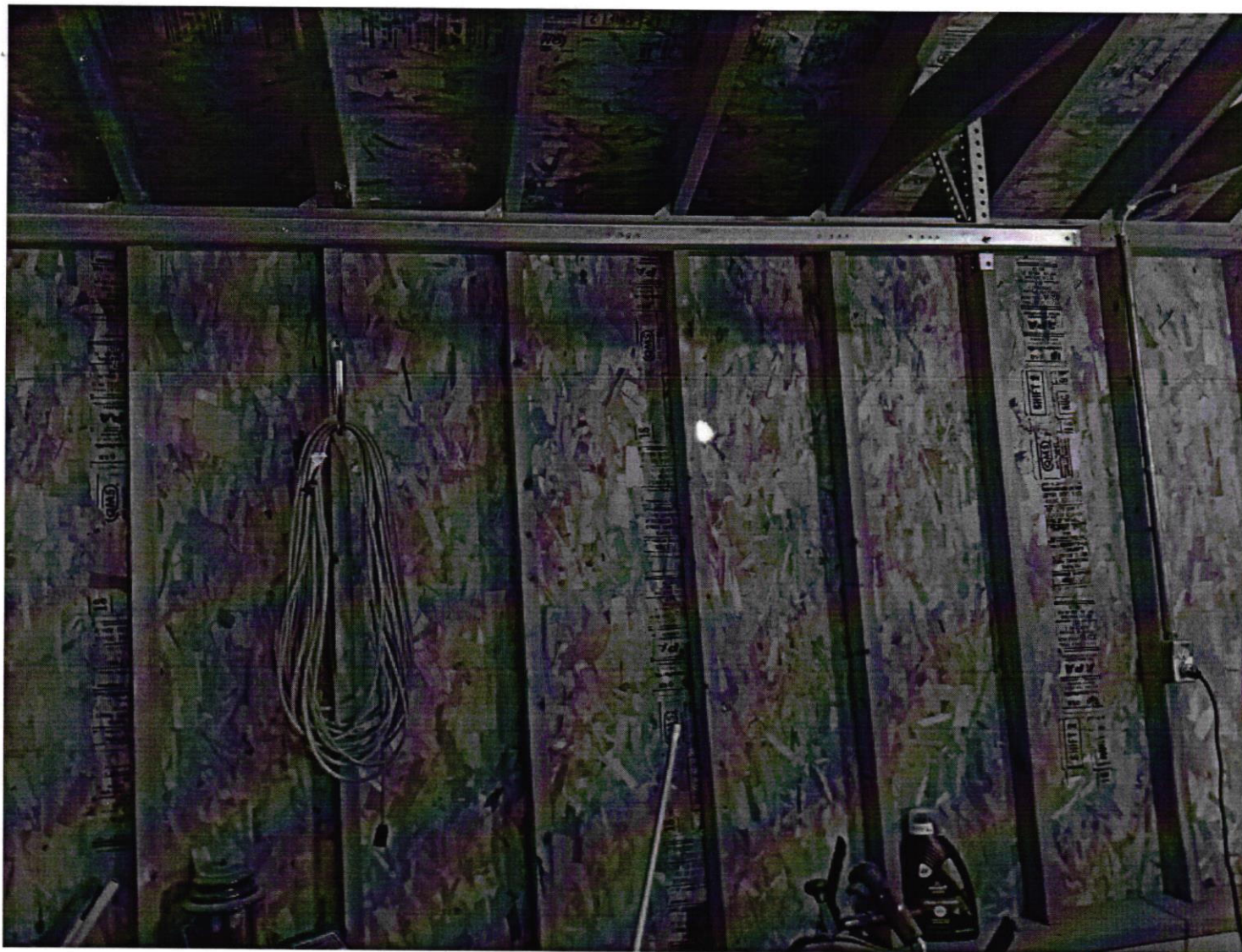
- 1) This estimate / proposal may be withdrawn if not accepted within 30 days from date on front side unless otherwise stated.
- 2) Contractor is covered by workmen's compensation and public liability insurance.
- 3) All materials & labor are guaranteed as specified on front side.
- 4) Any alteration or deviation from specifications involving extra work will become an extra charge over and above the estimate, if needed and authorized.
- 5) All verbal agreements between contractor and buyer involving job description are void unless written and signed by both parties on this contract.
- 6) Buyer represents that he or she is in fact the legal owner or authorized agent of the premises on which labor and materials are to be performed.
- 7) Contractor not liable for landscaping or cracking of concrete due to original construction (I.E. Thinness - Quality- Age).
- 8) All agreements are contingent upon accidents, or delays beyond our control.
- 9) The buyer assumes the responsibility for damage to underground sprinklers, sewer, sump pump discharge, and electrical lines to lights, garages, pools, etc. Note: Contractor, if notified by the buyer of the location, direction, and depth, will take precautions as best as possible, but contractor "not" liable.
- 10) A 1.5% interest charge per month will be enforced on all invoices not paid by designated terms of this agreement. All accounts are to be paid at completion or as otherwise stated on face of contract.
- 11) Guarantee to be effective on the date of completion, but shall not apply if payments are not made within terms as stated on the front side of contract. 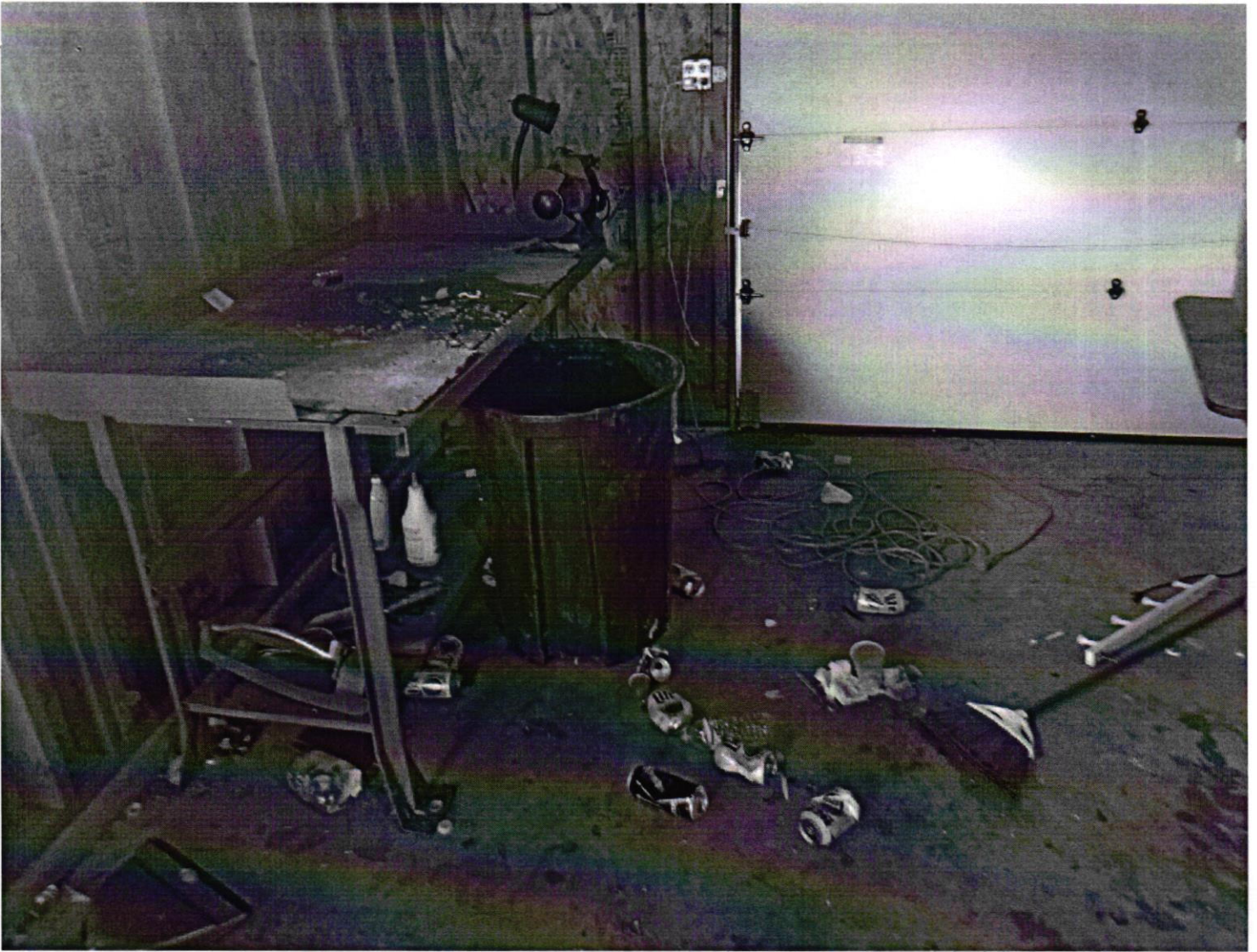

inside of garage

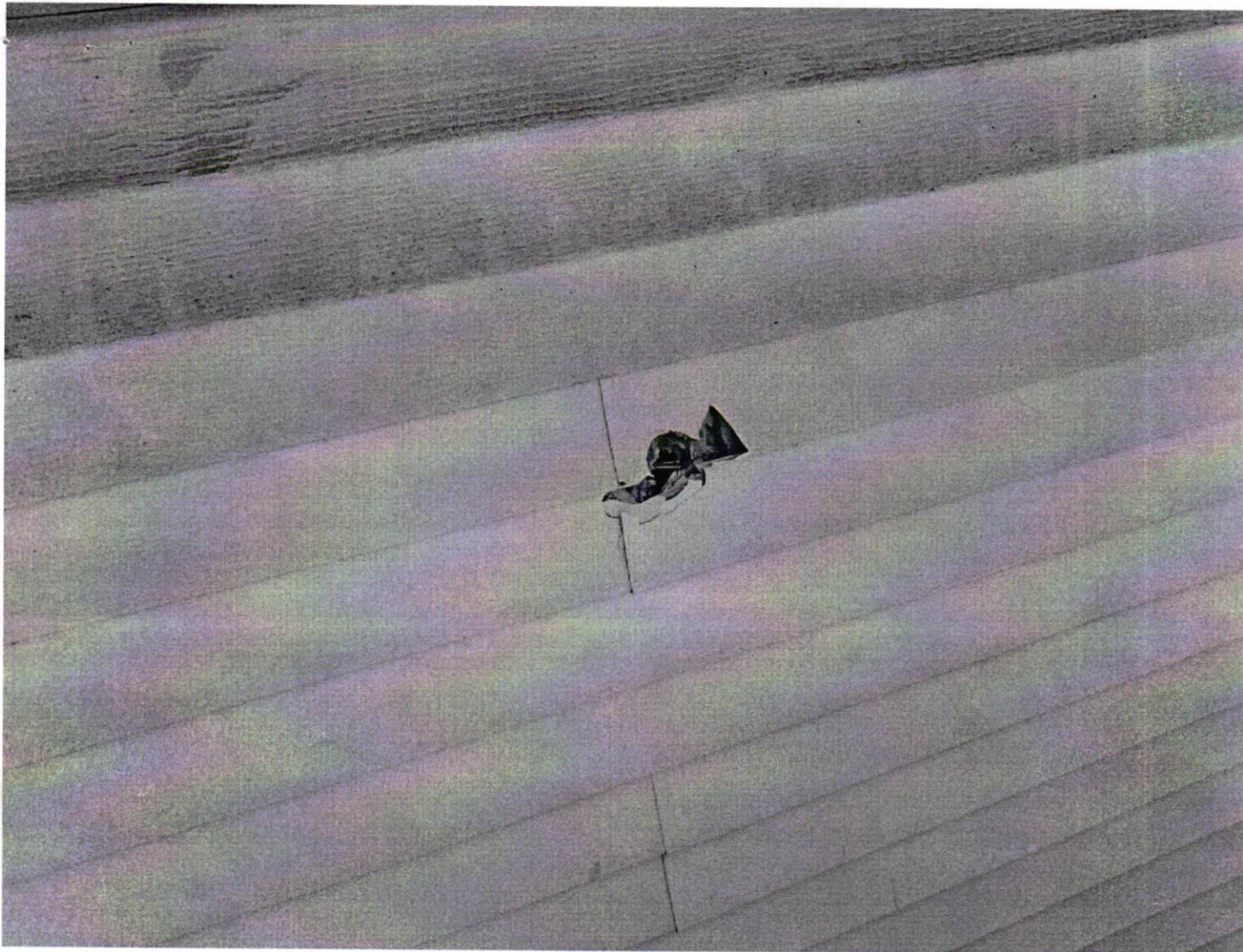

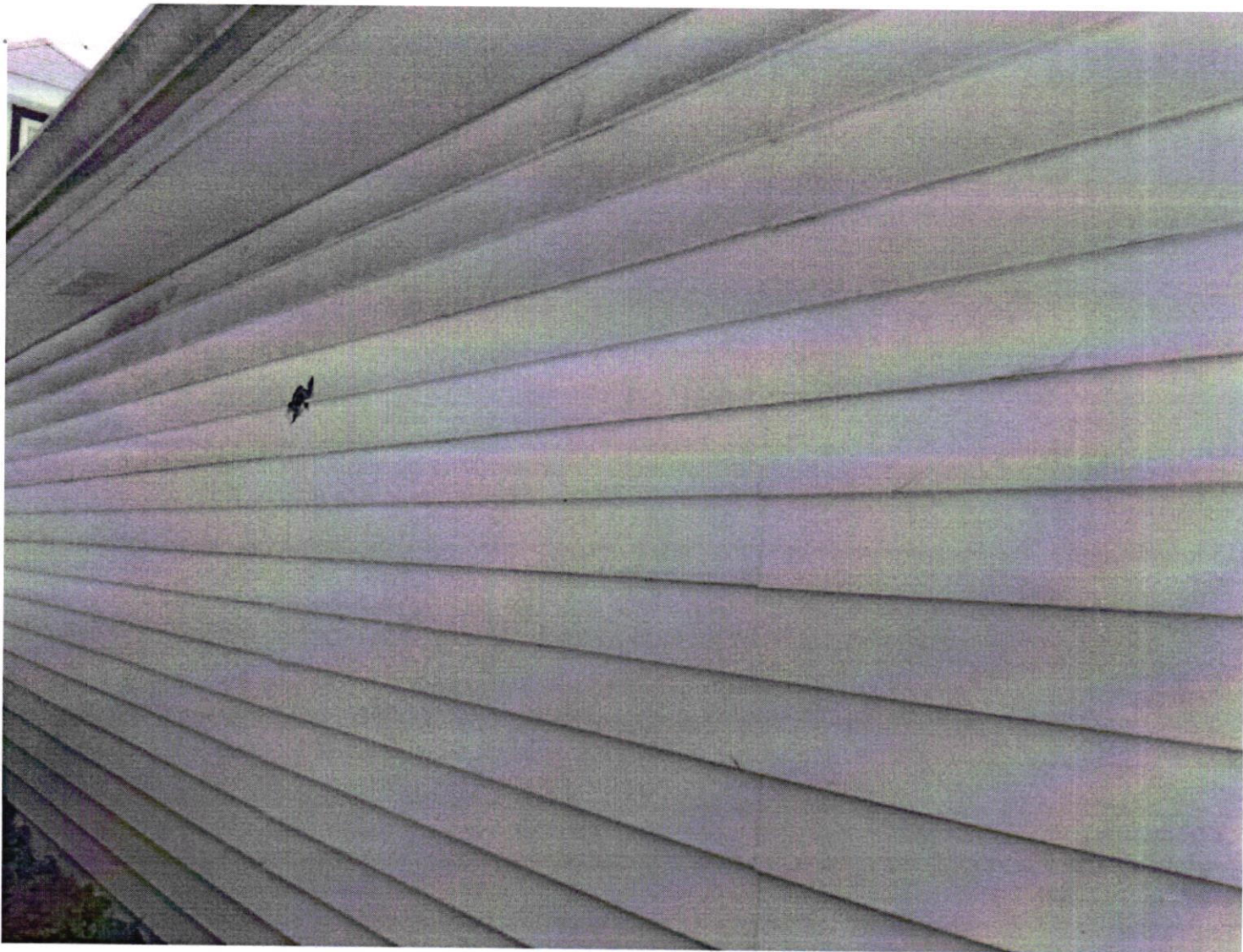

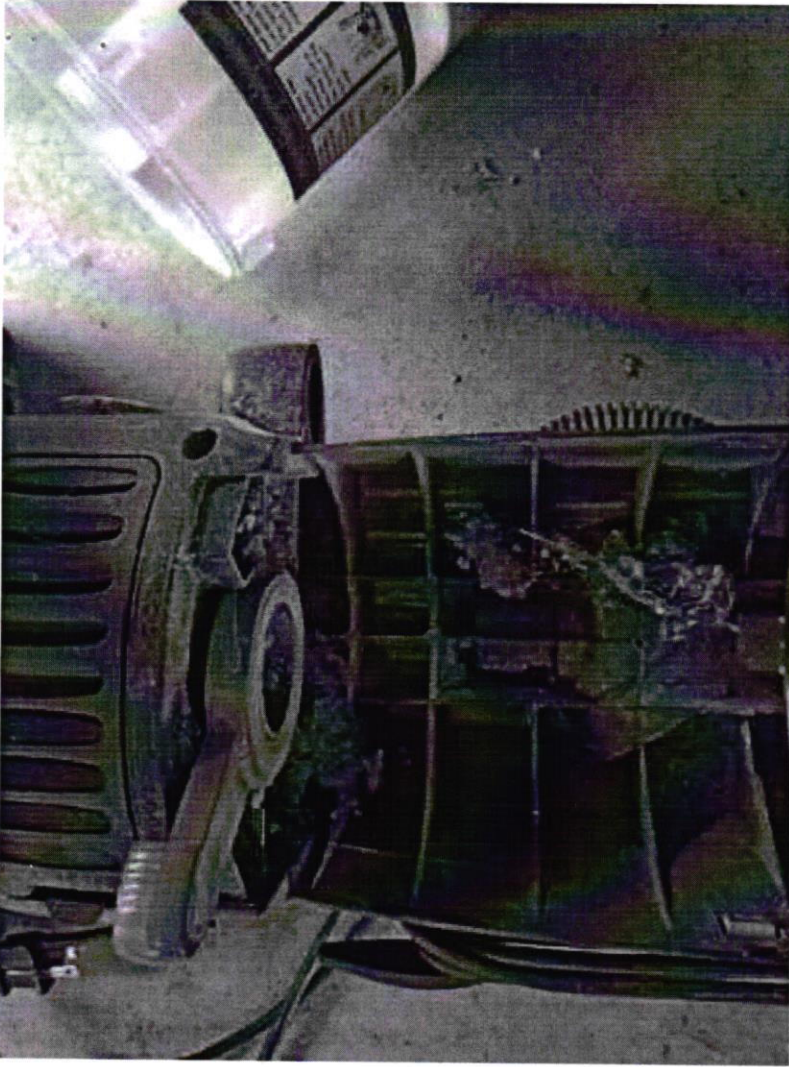


projectile exit point on
