Mr. Schloss shared with the committee that in response to the COVID pandemic and federal government response under the Cares Act, the City of West Allis received an additional \$762,000 to address the economic and social impacts of the emergency declaration. A budget and activities associated with these funds was shown.

Consideration of mid-year Performance Report for 2020 and expenditures for the period covering January 1, 2020 through June 30, 2020

Each activity within the mid-year Performance Report for 2020 and expenditures was addressed by Mr. Schloss. The committee was also informed on budgeted amounts and amounts expended for each activity from January through June 30, 2020. It was also noted that HUD awarded \$1,295,317 in entitlement funds, which was \$46,011 more than staff had anticipated.
