his dog to separate it. Anderson was advised by patrons in the bar that Davey struck his dog and is observed yelling at Davey to leave. Davey and Catalano eventually left the bar without incident. There was no physical contact between anyone at the bar and video surveillance showed Davey exaggerated or was untruthful with his statement. Davey was determined to be the aggressor however there were no complainants from the tavern against Davey. Anderson's living quarters are separated by a sliding door of the bar and was advised to keep his dogs inside of his residence. Anderson was cooperative and returned the dogs to his residence.
