RESOLUTION TO AUTHORIZE A TRANSFER OF \$7,500 FROM THE INFORMATION TECHNOLOGY SALARY AND WAGES ACCOUNT TO THE INFORMATION TECHNOLOGY – PROFESSIONAL SERVICES ACCOUNT TO ENGAGE SYMBIONT TECHNOLOGY INC. TO DELIVER ESRI BASED SOLUTIONS THAT WILL ENABLE DPW TO EDIT GIS INFORMATION

WHEREAS, An opportunity has presented itself to move work that had been conducted on the IT GIS Team to the members of the DPW department. DPW is willing to do this work, as it increases their accountability, gives them a greater sense of ownership. DPW is the group that is adding, moving and retiring most of the City's physical assets and thus should be empowered mark their location in our GIS system. The benefits are numerous to both DPW and GIS. Largest benefits include the elimination of handoffs and is directly aligned with LEAN thinking; and,

WHEREAS, the West Allis based company Symbiont Technology has recently delivered a very similar 'app' that the Engineering Department used to rate the condition of all the streets in the City of West Allis. After talking with them they feel they can leverage those same ESRI based tools to provide similar apps to the Building and Sign, Forestry and Electrical divisions to allow them to safely update the location of assets they maintain; and,

WHEREAS, the agreement with Symbiont includes a block of hours for them to train our GIS Analyst on how to build these same solutions for future needs for the City; and,

WHEREAS, with the GIS Administrator resigning on September 25th we have the salary dollars available to help fund this effort.

NOW THEREFORE, BE IT RESOLVED by the Mayor and Common Council of the City of West Allis that the change request dated November 11th 2020 for providing GIS editor apps from Symbiont Technology for the City of West Allis for the net sum not to exceed \$7,500 be and is hereby accepted. The account where this will be charged to is account # 100-1101-517.30-02 with money transferred from 100-1101-517.11.01.
