**RESOLUTION TO AUTHORIZE A TRANSFER OF \$15,250 FROM THE
INFORMATION TECHNOLOGY SALARY AND WAGES ACCOUNT TO THE
INFORMATION TECHNOLOGY – PROFESSIONAL SERVICES ACCOUNT TO
CONDUCT A GIS ARCHITECTURE AND APPLICATION ASSESSMENT BY GISINC**

WHEREAS, On September 25th the GIS Administrator resigned from the City presenting us the opportunity to look differently at how we want to deliver future GIS Services for the City; and,

WHEREAS, ESRI, the firm who's software we use to support our GIS platform, gave us several consulting firms to consider to help us with an assessment and produce a forward looking roadmap on how to get the most out of our investments in their products. After reviewing these consulting firms offering and conducting phone interviews we feel GISinc is the firm that best meets the needs of the City of West Allis; and

NOW THEREFORE, BE IT RESOLVED by the Mayor and Common Council of the City of West Allis that the contract dated November 11th 2020 for providing a GIS architecture and application assessment from GISinc for the City of West Allis for the net sum not to exceed \$15,250 be and is hereby accepted. The account where this will be charged to is account # 100-1101-517.30-02 with money transferred from 100-1101-517.11.01.


