## CITY OF WEST ALLIS ORDINANCE O-2021-0027

## ORDINANCE TO AMEND THE OFFICIAL ZONING MAP WITH THE REMOVAL OF A PDD-2 OVERLAY, PLANNED DEVELOPMENT DISTRICT (PDD-2 COMMERCIAL), AT 11013 AND 11111-17 W. GREENFIELD AVE.

**WHEREAS,** for the purpose of promoting the health, safety, morals or the general welfare of the community, the common council may divide the city into districts of such number, shape, and area as may be deemed best suited to carry out the purposes of Wis. Stat. 62.23; and

**WHEREAS**, the council finds that the amendments within this ordinance are in accordance with the comprehensive plan; and,

**WHEREAS**, the amendments within this ordinance have been submitted to the city plan commission for recommendation and report, published as a class 2 notice, and the subject of a public hearing;

**NOW THEREFORE,** the common council of the City of West Allis do ordain as follows: SECTION 1: AMENDMENT The zoning map identified in Section 12.05 of the City of West Allis Municipal Code is hereby amended by removing/rescinding the PDD-2 Planned Development District, Commercial overlay zone for the property located at 11013 and 11111-17 W. Greenfield Ave. (Tax Key No. 448-9993-009 and 448-9993-006) and retaining the underlying C-3 Community Commercial District zoning. The subject area is legally described as follows:

A tract of land being located in the Northeast ¼ of Section 6, Township 6 North, Range 21 East, City of West Allis, Milwaukee County, State of Wisconsin, describes as follows:

Lots 1 and 4 of the Certified Survey Map No. 5671.

Said land contains 8.599 Acres, more or less. The removal of the PDD-2 District also includes portions of City right-of-way (to the centerline of W. Greenfield Ave).

SECTION 3: ZONING MAP UPDATE The Zoning Map shall be updated to depict the amendments within this ordinance as indicated on Exhibit A.

SECTION 4: EFFECTIVE DATE This Ordinance shall be in full force and effect on and after the required approval and publication according to law.
