b. Memorial Day Program

As we decided last meeting, the Memorial Day parade will be cancelled and we will be hosting the Service/Ceremony program. Ms. White has been communicating with Mark

Sandow who helps each year, Ald. Dan Roadt, Larry from Tanner Paull, and Mary Pat Michels to coordinate the program.

c. Independence Day Festivities

Mr. Barwick has been communicating with State Fair Park on the contract for holding the Festival Foods Fireworks Show, he should have more updates at our next meeting.

The committee has decided to move forward with hosting the Independence Day on July 2. Several communities around us will also be hosting their parades this year, so we will continue to cautiously move forward with our scheduled parade as well. The program after the parade run by the Rec. Department will not be happening this year. Ms. White, Ms. Strasser, and Mr. Matte will be reviewing the parade contract and application in the next week, and aiming to get the registration form on our website by April 30.

Mr. Barwick gave an update on the Rotary Satellite Club's involvement with running this event, and they are ready to get into planning the details for this event in September. Ms. White will be sending Mr. Barwick a list of potential dog focused vendors to reach out to and a map of the market space to get an idea of vendor locations. This event will run from 12-4pm.
