**RESOLUTION TO APPROVE BID OF C.W. PURPERO, INC. FOR THE
RECONSTRUCTION OF MUNICIPAL PARKING LOTS AT S. 71ST ST. TO S. 72ND
ST. AND W. GREENFIELD AVE. TO W. ORCHARD ST. AND S. 73RD ST. TO S. 74TH
ST. AND W. GREENFIELD AVE. TO W. ORCHARD ST. IN THE AMOUNT OF
\$640,230**

WHEREAS, The Board of Public Works reports that it duly advertised for bids for the furnishing of certain materials and the performance of all work required for the improvements in a certain area as hereinafter described; that the bids received as shown on the attached bid report were reasonable and hereby recommends and deems it to be for the best interests of the City of West Allis that the bid of C.W. Purpero, Inc. for 2021 Project No. 15 be accepted.

NOW THEREFORE, BE IT RESOLVED By the Common Council of the City of West Allis that the bid of C.W. Purpero, Inc. for 2021 Project No. 15 for:

the installation of Bioretention Devices, Permeable Interlocking Concrete Pavement Systems, 4" asphalt pavement over 8" dense graded base course, curb and gutter replacement, miscellaneous concrete sidewalk, concrete driveway approaches, storm sewer and storm inlet replacement, light poles, and landscaping in:

South 71st Street to South 72nd Street and West Greenfield Avenue to West Orchard Street
South 73rd Street to South 74th Street and West Greenfield Avenue to West Orchard Street
(PLAN FILE NO. B-833)

for the sum of Six Hundred Forty Thousand, Two Hundred Thirty & 00/100 dollars
(\$640,230.00)

be accepted, and the proper City officers are hereby authorized and directed to enter into contractual relations with said contractor for the performance of said work, in accordance with the prices submitted in their proposal and with the specifications of the City of West Allis, and that all other bids received for same be rejected; and,

BE IT FURTHER RESOLVED That said improvements be installed with funding by Storm Water Funds and Bond Funds.


