

NARRATIVE

Officer Foy reports...

DISPATCH TO CALL/ARRIVAL ON SCENE

On 7/11/19 at 2239hrs officers responded to Remedy, 1309 S 60 St for a report of a male party who was exposing himself in the parking lot. Dispatch advised the male was walking towards the Taco Bell wearing a light plaid shirt and khaki shorts.

I arrived at the Taco Bell and was approached by an older male in a van who pointed to the bus depot and stated the male involved was sleeping in the bus depot. I walked over to the stop and located the male who was wearing the same clothing that dispatch advised was involved. I stopped and made contact with the male party.

STATEMENT OF OFFENDER - ISMAEL RAMOS

I spoke with Ismael Ramos as he was spilling his tacos all over himself. Ramos was highly intoxicated. He had difficulty speaking at he slurred his words so heavily that it was difficult to understand him. Ramos emitted a strong odor of intoxicants and displayed red and glassy eyes.

Ramos admitted he was coming from Remedy after he consumed one drink and then was refused any further service. Ramos stated he left the business and did not have any problems at the business or issues with any other customers. I asked Ramos if he urinated outside of the business and he denied it. Ramos stated he urinated once he got into the Taco Bell and ordered food.

Ramos admitted he was highly intoxicated but denied ever exposing his genitals to anyone or urinating outside of the business.

ARREST DECISION

Based upon the witness statement that showed where Ramos had urinated outside of the business, Ramos was detained for Disorderly Conduct.
