NARRATIVE**TAVERN COMPLIANCE OUTLINE**

On 09/08/18 from approx. 1500 hrs to 1800hrs., officers conducted a tavern check at 11 randomly selected West Allis Businesses that have a license to serve alcohol in a tavern setting. The check was completed through the use of [REDACTED] year old female identified as [REDACTED] [REDACTED] F/W [REDACTED] (Community Services Officer).

CSO [REDACTED] was assigned to enter each of the randomly selected businesses and

attempt to purchase an alcoholic drink. If the bartender refused to sell the alcohol, she was to leave the business. She was advised she could tell them she was of age, if they asked. If the bartender asked for her ID, she could say she left her ID at home, but she was not to use any extra attempts to purchase the alcohol by pleading and/or encouraging the clerk to complete the transaction.

CSO Vazquez was advised that if the transaction was completed, she was not to drink the alcoholic beverage. She was advised to leave the business and wait for officers to meet up with her outside of the tavern.

Officers were provided funds from the WAPD Community Services Bureau for the attempted purchases. For the compliance checks, CSO Vazquez did not have any identification cards with her date of birth on her person.

A photograph was taken of CSO Vazquez (in plain clothes), with a department issued digital camera to document her appearance on the date in question. The photograph was taken by PO Niemuth and later uploaded to the secured DIMS server for safekeeping.

On 09/08/19 at approx. 1557 hrs., officers performed a tavern check at Remedy Bar, 1309 S. 60 St. Officer Niemuth and I entered the business in plain clothes and sat at the bar. CSO Vazquez entered the business approx. five minutes after us. CSO Vazquez sat at the east end of the bar, and she ordered a bottle of Miller Lite. The male bartender completed the transaction without asking for her ID. Shortly after CSO Vazquez received her beer, she left the business. The bartender was M/W, longer hair, approx. 5'10", approx. 40's, and thin build.

CRAWDADDY'S RESTAURANT

On 09/08/19 at approx. 1732 hrs., officers performed a tavern compliance check at CrawDaddy's restaurant, 9427 W. Greenfield Ave. Officer Niemuth and I entered the business in plain clothes and sat at the bar. CSO Vazquez entered the business approx. five minutes after us. CSO Vazquez waited at the bar several seats away from us, and she ordered a Miller Lite bottle. The female bartender completed the transaction without asking for her ID. Shortly after CSO Vazquez received her beer, she left the business. The bartender was a F/W, approx. 5'5", 40-50's, and average to heavier set.

FOLLOW UP

On 09/09/19, I made contact with Troy M. Meyer, M/W [REDACTED] via phone and advised him of the incident. He said the bartender working at the time was "Debbie". He said he would contact me later with her information.

On 09/09/19, I made contact with Erwin C. Magritz, M/W [REDACTED] at Remedy. I advised him of the incident. I described the bartender, and he said his name was Ed Unke. I checked locals and ran his information through DOT for a DOT photo. He was confirmed to be Edward F. Unke, M/W [REDACTED].

CASE DISPOSITION

On 09/08/19, officers conducted tavern checks at 11 businesses. Two businesses (Remedy, 1309 S. 60 St., and Crawdaddy's Restaurant, 9427 W. Greenfield Ave.) completed the transactions without checking identification.

The owners were contacted and the bartenders were ultimately cited.

The remaining funds from the tavern checks were returned to Community Services. The tavern report was completed for Remedy.
