Your application was considered for denial based on the following reason(s):

- 1. Conviction(s) for a felony, misdemeanor, or other offense
- 2. Habitual law offenses

The circumstances of the offense(s) substantially relate to the operation of a licensed premise because irresponsible or illegal use of alcohol and/or drugs are an element of the offense(s) and/or noncompliance with licensing rules and regulations are an element of the offense(s).

As required by Wis. Stat. § 111.335(4)(c)1.b., you are allowed to show evidence of rehabilitation and fitness to engage in the operation of a premises licensed to serve alcohol. If you would like to present your evidence before the License and Health Committee on Tuesday, January 28, 2020 at 6:00 p.m. in Room 128, West Allis City Hall, 7525 W. Greenfield Ave., please notify Ann Marie Neff at (414) 302-8202, aneff@westalliswi.gov, no later than 4:00 p.m. on Thursday, January 23, 2020. If you do not request a hearing by that date and time, you will waive that opportunity. As a result, the License and Health Committee will be unable to hear your evidence and your license application could be denied.
