**RESOLUTION TO AMEND THE BUDGET OF THE FY 2021 COMMUNITY  
DEVELOPMENT BLOCK GRANT PROGRAM FOR THE BURNHAM POINTE  
PARK AND PEDESTRIAN IMPROVEMENT PROJECT IN THE AMOUNT OF  
\$25,000**

**WHEREAS**, the Common Council of the City of West Allis approved the FY 2021 Annual Action Plan for the Community Development Block Grant program under Resolution #R-2021-0157 that included approval for a Burnham Pointe Park and Pedestrian Improvement Project in the amount of \$97,494; and,

**WHEREAS**, the total project was approved for \$394,945 through various years of CDBG allocations; and,

**WHEREAS**, after completing the project, there is a need to install waste receptacles throughout the Burnham Pointe Area that would help address litter and help clean-up the neighborhood; and,

**WHEREAS**, the expense is eligible under the Community Development Block Grant Program and the Planning and Zoning Program.

**NOW THEREFORE**, BE IT RESOLVED by the Common Council of the City of West Allis that the FY 2021 Community Development Block Grant Program for the Burnham Pointe Park and Pedestrian Improvement Project budget be increased in the amount of \$25,000.
