PO Baumgart reports: On 11/10/17, at approx. 1448 hrs, I was dispatched to Rockstar Saloon, 5826 W Burnham St, for the report of an intoxicated male that was refusing to leave and fell down on the floor. Upon arrival, I located a male party, verbally identified as Jeffrey M. Fischer, m/w, 12/31/75, passed out in the vestibule of the Rockstar Saloon with blood coming from his mouth and nose. I woke Jeffrey up and called for an ambulance as Jeffrey could not remember his last name, his injury to his mouth or falling. He was conveyed to AWAMC for treatment. I spoke with the bartender, identified by WI ID as Jerome J. Pflugradt, m/w, 08/28/91. Jerome said Jeffrey was fine when he arrived at the bar at approx. 1300 hrs and Jerome served his 4 short Southern Comfort and Cranberry drinks. When Jeffrey was too intoxicated to stand, Jerome refused to serve him further. Jeffrey was escorted outside of the bar. Based on the statement of Jerome, it is believed Jeffrey was over-served alcoholic drinks at this establishment.
