Resolution to confirm and adopt the report of the Director of Public Works/City Engineer containing the schedule of proposed assessments for improvement of the East/West alley between S. 72 St. - S. Cleveland Ave. by asphalt resurfacing of the alley pavement, storm sewer relay and utility adjustments.
