At that time their was another tenant closing out their business with Sue and the city due to be closed at the end of June, 2016. So once James and I agreed to paying Sue \$10,000.00 security deposit \$7000.00 to be held as deposit and \$3.000.00 for July rent i signed the lease and we began business. Tonja Bassett was asked if she could be the agent she agreed. Sue, James and I agreed to add Tonja as agent. James and I as owners is 100% responsible for the business and share 50% ownership of Jm 6500 bar and grill. I picked up the Licenses application from Ann the city clerk and had Tonja to fill it out at her apartment. James works a full time day job at Grifols Blood Plasma so i quit my Job at Coke Cola to own and manage JM 6500 bar and grill. The J stand for James and The M for Montal in the business name. I have been at the bar since opening day working with all vendors, hiring all employees, cleaning, shoveling and addressing all police concerns during contact. I have always addressed any one with concerns as James and I being the owners of the establishment. Out of the 7 months Tonja has been at the business maybe 7 times since opening intill recent when she was fired from Harley. James is their 5 days out of the week after work or days off. I have the lease aswell only reason Tonja has one is because she needed it to become agent per West Allis request and she signed a dupicate one provide by Sue Jesion. James and i payed the downpayment copie of cashier checks can be provided. We purchased liqour, food, t.v and had all work done to get business open. We also purchased ice machine and e.t.c from previous business owner. I was their to meet all inspectors for initial inspection and follow up and mention to all i was the owner. James and i are listed on the business Insurance, merchant acct, waste company. We Energies, bank accounts and all vendors as the owner. Half of the business vendors i work with and customers have never met Tonja intill recent. So after meeting with Ald Mike.C of are district i am sending this letter to contest the ownership and to ask for it to be resolved at an common council hearing before the board.
