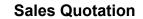

Overview:

Key Code media is going to install 16 new wireless conference units with 16 dual flex wireless gooseneck microphones. In addition, we will integrate a new Digital Signal processor that will be programmed to mix all the audio in the room. A listen technologies RF Transmitter will be installed in the council chamber, room 128 and the Art Gallery and a network server will be integrated for the hearing impaired over IP. Training on the solution will be included as well. As a second Phase to the project an Audio DSP will be installed in the Art Gallery. A new Rack will be installed as well to house the new Audio DSP, Amp and Gear.

Client Responsibilities:

Client is responsible for making sure the room is ready for Key Code to come in on four consecutive days to complete integration and training of said system. We will need 5 IP addresses on the City network for connection of new equipment. Also Balanced Audio cable will need to be run from each of the 3 rooms back to the control room for the hearing loop equipment. Speaker Cable will need to be run from the Art Gallery to the Specific Speaker locations, and this can be done by KCM if needed.

Timeline:

The time line for this project will be determined by equipment availability as well as schedules of Key Code integration team and the City of West Allis team. Current equipment lead time is 8-10 weeks.
