

**CITY OF WEST ALLIS
ORDINANCE O-2021-0111**

**ORDINANCE APPROPRIATING THE NECESSARY FUNDS FOR THE OPERATION
AND ADMINISTRATION OF THE CITY OF WEST ALLIS FOR CALENDAR YEAR
2022**

WHEREAS, the City of West Allis is required to adopt an annual budget pursuant to Wis. Stat. 65.90 and Section 1.04 of the West Allis Municipal Code; and

WHEREAS, a public hearing on the proposed budget was held on November 2, 2021;

NOW THEREFORE, the common council of the City of West Allis do ordain as follows:

SECTION 1: **ADOPTION** “2022 Annual Budget” of the City Of West Allis Municipal Code is hereby *added* as follows:

ADOPTION

2022 Annual Budget(*Added*)

PART I. The amounts budgeted as General Fund Revenues and Expenditures shall be as noted in Attachment 1.

PART II. All other expenditures and revenues as outlined in the 2022 Common Council Adopted Budget are hereby appropriated and budgeted.

PART III. The amount levied for the year 2022 as a tax (exclusive of the TIF levy) upon all 2021 taxable property within the City of West Allis, as returned by the Assessor, for the uses and purposes set forth in the budget, presented herewith, shall be as follows:

General Fund	\$ 40,447,255
Debt Service Fund	\$ 4,333,919
Parking Utility	\$ 43,000
Total Tax Levy	\$44,824,174

PART IV. The City Treasurer is authorized and directed to spread the said tax upon the current tax roll of the City of West Allis.

SECTION 2: **EFFECTIVE DATE** This Ordinance shall be in full force and effect on and after the required approval and publication according to law.
