Discussion regarding amendments to Section 9.105 Shooting Galleries and Gun Ranges of the Revised Municipal Code.

Discussion ensued regarding if there are set standards or codes for constructing and operating a safe indoor shooting range, if there are there any agencies that inspect this type of business, or if the state does inspections. Ed Lisinski, Director of Building Inspections & Neighborhood Services stated that his department and inspectors can't approve inspections without set standards or criteria to follow. Attorney Cerwin commented that in his search there was very little information regarding what other municipalities use for regulations. The Committee questioned if there are any agencies that do this type of inspection work, and if the inspection fee could be passed along to the shooting range applicant. It was suggested to contact Brookfield who has just recently opened up a new indoor shooting range to see what criteria they may have used.
