Patricia Ochs, 6420 W. National Ave., commented that the building has had multiple owners in the past, on the minor work that has been done, on the rodent activity, that the conduit has been ripped out, that there have been signs of people living in the building, that the building has a lot of problems, and that a dumpster has been placed there but never taken care of. Ms. Ochs stated that her landlord has an interest in purchasing the property for razing and building a parking lot, and that she would have an interest in purchasing some of the items if it is razed. Ms. Ochs said she has been cleaning up the area between the buildings of various debris, she would like self supporting fencing to prevent people from going between the buildings and leaving their trash.

Attorney Rodney Carter, representing Midwest Commercial Funding, 555 E. Wells St., Milwaukee, commented on the foreclosure of a number of loans, properties, and obligations by the previous owner of this building. Mr. Carter requested the granting of the Special Use, is aware of the problems with the property, is willing to adhere to the strict deadlines, will comply with the City, and intends to be a good neighbor. Mr. Carter said that Midwest Commercial Funding is a business property owner in the City already and has not been a problem.

Rob Chandler, Midwest Commercial Funding, 1521 Waukesha Rd. Caledonia, stated the Company is aware of the property issues, they have put together a plan to bring this property back to a sellable state and to get a tenant. Mr. Chandler said they have worked on other projects in the City, are capable of repairing the property, and want the opportunity to work on this building.
