C. NEW AND PREVIOUS MATTERS

1. [18-00707](#) Site, Landscaping and Architectural Plans for Great Midwest Bank, an existing business located at 10269 W. National Ave., submitted by VJS Construction Services on behalf of Great Midwest Savings and Loan (Tax Key No. 485-9989-002).

Discussion ensued with questions being answered by staff.

Mr. Eimon stated he would rather not include landscaping around the ATM for security reasons, but will as landscaping plans are forthcoming around the ATM.

Mr. Eimon expressed concern that they will be disallowed a monument sign. Staff indicated a monument sign would be approved in accordance with the sign ordinance. The Plan Commission granted two years to the bank to come into compliance with the sign ordinance relative to removal of the existing pole sign.

Recommendation: Recommend approval of the Site, Landscaping and Architectural Plans for Great Midwest Bank, an existing business located at 10269 W. National Ave., submitted by VJS Construction Services on behalf of

Great Midwest Savings and Loan (Tax Key No. 485-9989-002), subject to the following conditions:

(Items 1 through 3 are required to be satisfied prior to the issuance of building permits associated with the proposed work reviewed by Plan Commission. Contractors applying for permits should be advised accordingly.)

1. Revised Site and Landscaping Plans being submitted to the Department of Development to show the following: (a) landscaping area around the future/updated ATM; (b) landscaping species subject to City Forester approval. Contact Katie Bennett, City Planner at 414-302-8463.
2. An estimated cost of landscaping being submitted to the Department of Development for approval. Contact Katie Bennett, City Planner at 414-302-8463.
3. A surety bond or other form of security as required under Sec. 12.13(14) of the Revised Municipal Code in the amount of 125% of the estimated cost of landscaping and fencing shall be executed by the applicant prior to the issuing of a building permit. The security form shall be submitted to and approved by the Building Inspections and Neighborhood Services Department, relative to the cost estimate as determined in Condition #2. Contact Katie Bennett, City Planner at 414-302-8463.

(Remaining conditions of approval to be satisfied by the property owner within two years of Plan Commission approval)

4. Signage plan provided to Department of Development staff for review and approval.
5. Compliance with Section 2814 of the City's Policy and Procedures Manual relative to that policy as it relates to the replacement and repair to City walkways of damaged or defective (if any) abutting sidewalk.
