#### D. MATTERS FOR DISCUSSION/ACTION

**2.** <u>20-0222</u> 2020 Events Discussion

a. Virtual Tree Lighting

We will stream the Virtual Tree Lighting on the City's YouTube channel. WAWM Shining Strings will be performing in the Art Gallery, and Mayor Devine will light the tree outside with Ms. Feldmeyer's daughters. Ms. Rausch will check with Mr. Don Molleson to make sure all of the lights are working.

b. A Message from Santa

Ms. White asked committee members to share this fundraiser with anyone they know who may be interested. We'd like to get at least 5 submissions. John Roots, owner of Natty Oaks, has agreed to be our Santa for the filming of these videos and we can use a Santa Chalet at Natty Oaks - it's very festively decorated and the perfect back drop for these videos. Ms. White will write up scripts for each request that Santa will be able to read from. Bother Letters from Santa and videos will be sent those requesting.

c. Santa on the Go

Santa on the Go will be sponsored by the Christmas Parade Committee. Mark Klemme of Klemme Floats will be creating the float for Santa to ride on, it will be Christmas theme with holiday music playing. The float build/start location will now be at Allis Chalmers instead of DPW.

d. Veterans Giving Tree Updates

All virtual stars were chosen very quickly and Ms. White is getting inquiries about the generic gift option. If anyone else is getting questions, the generic gifts are just as important as the virtual stars, so we can continue to promote that. With all planned 2021 events, there will be an alternative COVID friendly version also planned. This will allow us to safely host events moving forward.
