- Emily Rutter, Adult Reference and Circulation Supervisor, and Michael Koszalka met with Shannon Byrne, the West Allis Senior Center Coordinator. They discussed ways the Library can collaborate with the Senior Center.

-An outreach event at Madison Elementary resulted in 27 new patron library card sign-ups. Beth Henika, Children's Supervisor, has also conducted story times at after school programs throughout the school district.

-Book A Librarian , a service providing one on one tech help to patrons, has restarted. Five patrons have already taken advantage of the service.

-The Library saw an increase of 1,500 visitors from February to March.

-On April 2nd, the Friends of the West Allis Public Library had their first meeting in two years.
