b. Virtual Veterans Giving Tree

This year, we would like to go all virtual with this program to avoid any foot traffic in City Hall. The VA is confirming our virtual plans and figuring out drop off days/times for gift drop off. Ms. White will continue communicating with the VA to finalize plans and then set up Signup Genius with Veteran gift lists.

### c. Tree Lighting

Our Annual Tree Lighting Program will be all virtual as well. WAWM Shining Strings will begin their performance at 4pm in the Art Gallery and Mayor Devine will light the tree at 4:45pm. Both activities will be streamed online for residents to watch as it happens.

#### d. Holiday Event Ideas

Ms. Lenz had some great ideas, two of which we discussed during this meeting. Expanding Candy Cane Lane will be discussed for next year, or potentially turned into a Halloween themed event. And offering virtual holiday crafting sessions would be fun, but timing may not work in our favor. Let's plan ahead for next holiday season.

We will be going with Ms. Feldmeyer's idea for A Message from Santa. For a donation of \$25, a family can get a custom video message from Santa (made by City employee Dave Danielson, and using a volunteer Santa). These videos will be completed and sent to families before Christmas, to hopefully spread some holiday cheer to children this year!
