NOW, THEREFORE, BE IT RESOLVED By the Common Council of the City of West Allis that the bid of Globe Contractors, Inc. for 2016 Project No. 11 for:

the installation of concrete curb and gutter, concrete pavement, concrete sidewalk, driveway replacement, sanitary sewer relay, storm sewer, storm sewer relay, water main relay, building services and utility adjustments in:

South 119th Street from West Oklahoma Avenue to West Ohio Avenue

(PLAN FILE NOS. SP-1221, S-1564, S-1565, W-1349,
W-1350, U-2617, U-2618)

for the sum of One Million, One Hundred Seventy-Two Thousand, Three Hundred Thirty-Eight and 00/100

dollars (\$1,172,338.00)

be accepted, and the proper City officers are hereby authorized and directed to enter into contractual relations with said contractor for the performance of said work, in accordance with the prices submitted in their proposal and with the specifications of the City of West Allis, and that all other bids received for same be rejected; and,

BE IT FURTHER RESOLVED That said improvements be installed with funding by Sanitary Sewer Funds, Storm Water Management Funds, Water Utility Funds, Bond Funds and Funds from Special Assessments.
