1. The report of the Interim City Engineer, including the schedule of the proposed assessments, for the improvement of S. 124 Street from W. Lincoln Avenue to W. Oklahoma Avenue and portions of intersecting streets by widening with a rural section asphalt pavement be and the same is hereby approved and adopted.
