WHEREAS, Kris Moen, the Deputy Finance Director, has agreed to be the acting Finance Director until a new Finance Director is appointed; and

WHEREAS, the Finance Department requires additional assistance until the new Finance Director is hired to complete its required duties and responsibilities.

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of West Allis that the City Administrator is authorized to enter into a professional services agreement with one or more of the following firms providing temporary finance staffing for a total sum not to exceed \$35,000 among all firms:
