WHEREAS, The City Engineer, pursuant to Preliminary Resolution No. R-2004-0043, adopted on February 18, 2004 and R-2004-0134, adopted on May 4, 2004, prepared and submitted his report as provided in sec. 66.0703 (5) of the Wisconsin Statutes, for improvement of the general area as hereinafter described; and,

NOW, THEREFORE, BE IT RESOLVED By the Common Council of the City of West Allis:

- 1. The report of the City Engineer, including the schedule of the proposed assessments, for improvement of the general area bounded by W. Burnham St., W. Cleveland Ave., S. 78 St. and S. 84 St. by replacement or repair of concrete sidewalk at random locations be and the same is hereby approved and adopted.
