WHEREAS, The City Engineer, pursuant to Preliminary Resolution No. R-2008-0218, adopted on November 5, 2008, prepared and submitted his report as provided in sec. 66.0703(5) of the Wisconsin Statutes, for the improvement of the street as hereinafter described; and,

WHEREAS, The City Clerk/Treasurer gave due notice that such report was open for inspection at his office and also at the office of the City Engineer, and that all persons interested could appear before the Common Council and be heard concerning the matters contained in the Preliminary Resolution and Report; and,

- 1. The report of the City Engineer, including the schedule of the proposed assessments, for the improvement of S. 101 St. from W. Cleveland Ave. to W. Oklahoma Ave. Service Drive by minor asphalt resurfacing with miscellaneous walk, miscellaneous driveway repair and utility adjustments be and the same is hereby approved and adopted.
- 2. The property against which the assessments are proposed is benefited; the assessments shown on the report are true and correct, have been determined on a reasonable basis and are hereby confirmed.
