for the sum of Eight Hundred Seventy Thousand, Five Hundred Fifty-One Dollars and Thirty Cents (\$870,551.30)

be accepted, and the proper City officers are hereby authorized and directed to enter into contractual relations

with said contractor for the performance of said work, in accordance with the prices submitted in their proposal and with the specifications of the City of West Allis, and that all other bids received for same be rejected; and,
