WHEREAS, Sally was an invaluable member of City of West Allis committees and planning teams, including the City of West Allis Executive Leadership Team; member of the City of West Allis Service Delivery Action Team; member of the City of West Allis Emergency Government Advisory Committee; member of the City of West Allis City Strategic Plan Development Committee; member of Rotary Club of West Allis; member of the Violence Free West Allis Collaborative; member of Healthiest Communities Designation Committee; and was invaluable in the development of our core values and competencies; and

WHEREAS, Sally was instrumental in achieving and maintaining accreditation status for the West Allis Health Department, and for providing leadership in the preparation of the Health Department's Community Health Assessment Plans, Community Health Improvement Plans, and departmental strategic planning; and
