- 4. North/South and East/West alley between S. 62 St. and S. 63 St.: W. Grant St. to W. Lincoln Ave.
- 5. North/South and East/West alleys between S. 65 St. and S. 66 St.: W. Grant St. to W. Lincoln Ave.
- 6. North/South and East/West alley between S. 67 Pl. and S. 68 St.: W. Grant St. to W. Lincoln Ave.
- 7. North/South alley between S. 71 St. and S. 72 St.; W. Rogers St. to W. Becher St.
- 8. North/South and East/West alley between S. 72 St. and S. 73 St.: W. Grant St. to W. Lincoln Ave.
