Resolution Relative to Vacation and Discontinuance of an Alley North of West Greenfield Avenue Between South 63<sup>rd</sup> Street and South 64<sup>th</sup> Street.

WHEREAS, the public interest requires that an Alley North of West Greenfield Avenue between South 63<sup>rd</sup> Street and South 64<sup>th</sup> Street, shown and legally described on the map of the City of West Allis Engineering Department dated March 9<sup>th</sup>, 2006, File No. Y-1152, which is attached hereto and incorporated herein by reference, be discontinued and vacated; and,

WHEREAS, this Resolution was introduced before the Common Council of the City of West Allis on March 21<sup>st</sup>, 2006; Notice of Pendency of the Resolution to vacate the aforesaid Alley was filed with the Register of Deeds of Milwaukee County on March 21<sup>st</sup>, 2006; and Notice of Hearing was published in the official City newspaper on April 6<sup>th</sup>, 2006, April 13<sup>th</sup>, 2006 and April 20<sup>th</sup>, 2006; and,

WHEREAS, no sufficient written objection to the vacation and discontinuance was filed with the City Administrative Officer, Clerk/Treasurer.

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of West Allis, in accordance with the authority vested in the Common Council by Sec. 66.1003, Wisconsin Statutes, that an Alley North of West Greenfield Avenue between South 63<sup>rd</sup> Street and South 64<sup>th</sup> Street, shown and legally described on the map of the City of West Allis Engineering Department dated March 9<sup>th</sup>, 2006, File No. Y-1152, which is attached hereto and incorporated herein by reference, be and the same is hereby vacated and discontinued, as required by the public interest.

BE IT FURTHER RESOLVED that certain public utility easements for gas, water, storm sewer, sanitary sewer and electric, upon, along, through and under the parcel of property shown and legally described on the map of the City of West Allis Engineering Department dated March 9<sup>th</sup>, 2006, File No. Y-1152, which is attached hereto and incorporated by reference, and rights incidental thereto, and all rights of entrance, maintenance, construction and repair of the same, shall continue following the aforesaid vacation pursuant to the provision of Sec. 80.32(4), Wisconsin Statutes.
