West Holt Avenue from South 119<sup>th</sup> Street to 290' East of South 122<sup>nd</sup> Street

for the sum of Seven Hundred Thirty-one Thousand Six Hundred Sixty-nine and 10/100 dollars (\$731,669.00)

be accepted, and the proper City officers are hereby authorized and directed to enter into contractual relations with said contractor for the performance of said work, in accordance with the prices submitted in their proposal and with the specifications of the City of West Allis, and that all other bids received for same be rejected; and,

BE IT FURTHER RESOLVED That said improvements be installed with funding by Sanitary Sewer Funds, Storm Water Management Funds, Water Utility Funds, Bond Funds and Funds from Special Assessments.
