- S. 63rd Street & W. Greenfield Avenue
- Library Station: S. 75th Street & W. National Avenue
- Veteran's Park Station: S. 70th Street & W. National Avenue
- Farmers Market Station: Southeast corner of S. 66th Street & W. Greenfield Avenue; and,
