BE IT FURTHER RESOVLED that the Common Council's approval of the Certified Survey Map is subject to and conditioned upon Element 84, LLC taking title of all seven (7) properties and receiving property owner certifications in accordance with WI State Statutes.

BE IT FURTHER RESOLVED with the grant of this resolution, that the Common Council grants an additional 6 month extension of time (June 7, 2017) to record the map and its documents with the Milwaukee County Register of Deeds Office.
