An Ordinance to amend Sections 12.06 and 12.41 of the Revised Municipal Code relative to defining and permitting Alcohol beverage sales (Class A License) as Special Uses within the C-2 thru C-4 Commercial and M-1 Manufacturing Districts.

The Common Council of the City of West Allis do ordain as follows:

PART I. Section 12.06 of the Revised Municipal Code of the City of West Allis is hereby amended to include the following term.

\*\*\*

Alcohol beverage sales. Any commercial premise requiring a Class “A” license in accordance with licensing requirements of the State of Wisconsin and Section 9.02 of the City of West Allis Revised Municipal Code to sell fermented malt beverages (beer and/or cider) and/or intoxicating liquor (including wine) for consumption off- premise.

PART II. Paragraph 12.41(1)(u), liquor stores (packaged liquor), is hereby repealed from the City of West Allis Revised Municipal Code.

PART III. Subsection 12.41(2) of the Revised Municipal Code of the City of West Allis is hereby amended to read:

(2) Special Uses.

(dd) Alcohol beverage sales (Class A License for original and/or transfer applications)

PART IV. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

PART V. This ordinance shall take effect and be in force from and after its passage and publication.
