installation of concrete curb and gutter, concrete pavement, concrete sidewalk, driveway replacement, sanitary sewer relay, storm sewer, storm sewer relay, water main relay, building services, street lighting and utility adjustments in:

**South 80<sup>th</sup> Street from West Greenfield Avenue to West National Avenue**  
**South 75<sup>th</sup> Street from North of West Walker Street to West Washington Street**

for the sum of Three Million, Five Hundred Thirteen Thousand, Seven Hundred Twenty-Five & 84/100  
dollars (\$3,513,725.84)

be accepted, and the proper City officers are hereby authorized and directed to enter into contractual  
relations with said contractor for the performance of said work, in accordance with the prices submitted in  
their proposal and with the specifications of the City of West Allis, and that all other bids received for same  
be rejected; and,

BE IT FURTHER RESOLVED That said improvements be installed with funding by Sanitary Sewer Funds,  
Storm Water Management Funds, Water Utility Funds, Bond Funds and Funds from Special Assessments.
