Installation of concrete curb and gutter, concrete and asphalt pavement, concrete sidewalk, traffic signal loops, pavement marking and utility adjustments in:

**South 113<sup>th</sup> Street from West Greenfield Avenue to West Lapham Street**  
**South 116<sup>th</sup> Street from West Greenfield Avenue to Union Pacific Railroad**  
**West Rogers Street at 350' East of S. 116<sup>th</sup> Street**

for the sum of One Million, Three Hundred Forty-four Thousand, One Hundred Twenty-one & 72/100 dollars (\$1,344,121.72)

specifications of the City of West Allis, and that all other bids received for the same be rejected; and,

BE IT FURTHERED RESOLVED That said improvements be installed with funding by Sanitary Sewer Funds, Storm Water Management Funds, Water Utility Funds, Bond Funds and Funds from Special Assessments.
