The report of the City Engineer, including the schedule of the proposed assessments, for the improvement of Hwy 100 from the North City Limits to the South City Limits by miscellaneous sidewalk repair, miscellaneous driveway repair and utility adjustments be and the same is hereby approved and adopted.
