Resolution to approve bid of LaLonde Contractors, Inc. for street construction in S. 82 St. from W. Greenfield Ave. to W. National Ave. and S. 82 St. from W. Burnham St. to W. Rogers St. in the amount of \$2,212,480.01

WHEREAS, The Board of Public Works reports that it duly advertised for bids for the furnishing of certain materials and the performance of all work required for the improvements in a certain area as hereinafter described; that the bids received as shown on the attached bid report were reasonable and hereby recommends and deems it to be for the best interests of the City of West Allis that the bid of LaLonde Contractors, Inc. for 2021 Project No. 3 be accepted.

NOW, THEREFORE, BE IT RESOLVED By the Common Council of the City of West Allis that the bid of LaLonde Contractors, Inc. for 2021 Project No. 3 for the installation of concrete curb and gutter, concrete pavement, concrete sidewalk, driveway replacement, sanitary sewer relay, storm sewer, storm sewer relay, water main relay, building services and utility adjustments in:

South 82nd Street from West Greenfield Avenue to West National Avenue
South 82nd Street from West Burnham Street to West Rogers Street

(PLAN FILE NOS. SP-1261, SP-1262, S-1261, S-1648, S-1649, S-1650, W-1406, W-1411,
W-1412, W-1413, U-2661, U-2668, U-2669, U-2670)

for the sum of Two Million, Two Hundred Twelve Thousand, Four Hundred Eighty & 01//100 dollars (\$2,212,480.01) be accepted, and the proper City officers are hereby authorized and directed to enter into contractual relations with said contractor for the performance of said work, in accordance with the prices submitted in their proposal and with the specifications of the City of West Allis, and that all other bids received for same be rejected; and,

BE IT FURTHER RESOLVED That said improvements be installed with funding by Sanitary Sewer Funds, Storm Water Management Funds, Water Utility Funds, Bond Funds, Municipal Street Improvement Program funds (MSIP), and Funds from Special Assessments.
